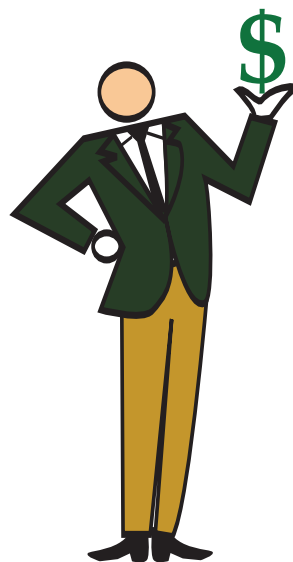

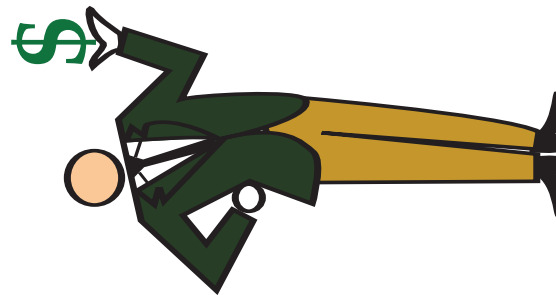
However, I am most proud of my involvement with the Big Brothers/Big Sisters program and being a single parent.
